CAP DAUPHIN REQUEST FOR A MINOR DEROGATION

WHEREAS a request for a minor derogation dated March 6, 2019 was submitted by Ruth Taker Thibodeau, General Manager of Cape Dauphin Fishermen's Cooperative and is accompanied by a projected implantation plan from the surveyor, Mr. Jean Boucher, file number 3760 of his minutes dated June 2, 2019;

such as dunes, beaches, coastlines and wetlands, and the importance of these environments for fauna, flora, lagoons and

other natural habitats:
