

## BYLAW 2006-05

### **BYLAW AUTHORISING THE REIMBURSEMENT OF THE JUNE 20, 2004 REFERENDUM FOR WHICH A LOAN IS REQUIRED TO COVER THE EXPENSES FOR AN AMOUNT OF \$37, 385 TO BE REIMBURSED OVER A FIVE YEAR PERIOD**

**WHEREAS** under the provisions of *An Act Respecting the Consultation of Citizens on Territorial Reorganisation of Certain Municipalities*, a referendum was held in the territory of Grosse Ile on June 20, 2004;

**WHEREAS** the cost of the referendum was thirty-seven thousand three hundred and eighty four dollars and ninety-three cents (\$37, 384.93);

**WHEREAS** it is necessary to contract a loan to pay the aforementioned expense;

**WHEREAS** a notice of motion was given at a regular sitting of council held March 1, 2006;

**WHEREAS** a draft copy of the present bylaw was given to each council member two days prior to the meeting; and

**WHEREAS** the members of council declare that they have read the present bylaw and renounce its reading;

### **THEREFORE**

**THAT** the following bylaw 2006-05 bearing the title “Bylaw Authorising the Reimbursement of the June 20, 2004 Referendum for Which a Loan is Required to Cover the Expenses for an Amount of \$37, 385 to be Reimbursed Over a Five Year Period” is hereby adopted and decreed by the following:

### **SECTION 1**

The preamble is an integral part of the present bylaw.

### **SECTION 2**

The council authorises an expense not exceeding thirty-seven thousand three hundred and eighty five dollars (\$37, 385) in order to reimburse the costs, incurred by the Director General of Elections Quebec, of the referendum held on June 20, 2004 in accordance to the provisions of *An Act Respecting the Consultation of Citizens on Territorial Reorganisation of Certain Municipalities*.

### **SECTION 3**

In order to reimburse the expense provided for by this present bylaw, the council authorises a loan for an amount of thirty-seven thousand three hundred and eighty-five dollars (\$37, 385) to be reimbursed over a period of five (5) years.

**SECTION 4**

In order to reimburse the expense decreed by this present bylaw, for an amount thirty-seven thousand three hundred and eighty five dollars (\$37, 385), the council authorises a loan for an amount of thirty-seven thousand three hundred and eighty-five dollars (\$37, 385), over a period of five (5) years, including professional fees, all related and unforeseen costs and all taxes and to allocate an amount of thirty-seven thousand three hundred and eighty five dollars (\$37, 385) from the general fund.

**SECTION 5**

This present bylaw shall come into force in accordance to the law.
